Ghana - Reinsurance Tax Increase



Effective January 1, 2023, the reinsurance premium tax in Ghana will increase from 1.5% to 1.73%. This is applicable to all lines of business.

Uganda - Anti-Money Laundering Documents for Foreign Reinsurers

The insurance regulator in Uganda is imposing strict requirements on foreign reinsurers and is closely monitoring all foreign reinsurance transactions. This is part of all anti-money laundering procedures to track any unauthorized reinsurance transactions in the country. As a result, any foreign reinsurer who wants to place reinsured business in Uganda will



have to provide the following documents as part of the KYC (Know Your Client) package:

- a) Completed and signed KYC Form
- b) Tax number of the reinsurer
- c) Copy of the Registration certificate for the reinsurer
- d) Copy of the proof of address for the reinsurer
- e) IDs/Passport copies for authorized legal representatives at the reinsurer's company

Kingdom of Eswatini - Reinsurance



The insurance regulator in the Kingdom of Eswatini, formerly known as Swaziland, is working on reducing the risks and premiums exported out of the country. These steps by the insurance authorities are lined up with the governmental intent to increase capacity within the region. Foreign reinsurers should keep in mind that former fronting may not be available going forth. Local capacity must be exhausted before any risk and

premiums can be sent overseas. Globex is checking with our sources on the ground for more information on this and will keep our readers updated.

Currency Devaluations Across Nations

Malawi and Colombia join the number of countries that have experienced a substantial devaluation of their local currency against the US dollar in recent months. In the case of both of these countries, the local currencies have devalued by more than 20%. Globex recommends that our partners be wary of these fluctuations and set a rate of exchange that will be acceptable to all parties involved, keeping in mind premium payments, reinsurance remittances, and claims payments.
