#### Argentina - New Tax Effective July 24th, 2023



Last month, our readers may recall that Globex shared some updates about a new tax that will be effective in Argentina. Globex required further clarification from our network partners on the ground as to the specifics of how the tax would be computed on local policy premiums. A new regulation was imposed, Decree/Decreto 377/2023 (DCTO-2023-377-APN-PTE), in the insurance regulatory code, and the tax would apply to any local premium with an

effective date of July 24, 2023.

The purpose of the new tax is to charge an extra 25% on any reinsured premiums that are ceded overseas. No reinsured premiums can be remitted without the payment of the tax to the insurance authorities. The party responsible for the payment of the new tax is the local insured. Any local reinsured policy with an inception date starting July 24, 2023, will have the new tax applied to the premium breakdown. ## Thailand - OIC Increases Tax from 0.6% to 0.8%

Globex's network partners on the ground shared with us that, effective October 1, 2023, the Office of Insurance Commission (OIC) has applied a new rate to the OIC Fee; the fee will increase from 0.6% to 0.8%. Any policy that is issued on or after October 1, 2023, will experience the rate increase. Globex's partners have made an exceptional case and will impose the higher tax starting January 1, 2024. This is due to the very short notice that the OIC provided. A big thank you to our network partners on the ground in Thailand!

## Uganda - Recent Changes in the Reinsurance Process



In the past, Africa was relatively flexible with cession overseas, as insurance regulators were flexible with the terms and conditions. In recent years, there has been a strong push from local and regional regulators to increase risk retention in Africa. The driving force behind the push to retain premiums and risk locally resides in the increased capacity being offered by local insurers and reinsurers, with the aim of improving infrastructure within the nations.

To ensure that premiums stay within the region, regulators started imposing restrictions on risk cession overseas, requesting regional and foreign reinsurers to be approved locally, or creating

regional reinsurers to keep an extra share of the risk (in addition to the local carrier's share).

Globex was informed last month that Uganda will now fall within the regions where cession overseas will see a marked decrease. We started to experience the restrictions in 2021, but thanks to our network in Africa, Globex was able to continue to offer 100% compliant and fronting solutions in Uganda. As recent as last month, increased diligence by the local authorities has resulted in fewer fronting solutions; local carriers will now have to retain a minimum of 5% of all risk and premiums within Uganda.
